WHEREAS, pursuant to the order, the recount was held on Monday, December 2, 2019 at 12:30pm at the Union County Voting Machine Warehouse, 2345 South Avenue, Scotch Plains ; and


NOW, THEREFORE, BE IT RESOLVED that there was a significant increase in votes cast and results for each of the candidates and it is hereby explained. The Board of Elections adjudicated and counted ten vote by mail ballots and three provisional ballots which were correctly determined by the vote tabulator machine as having overvotes (11 ballots) and undervotes (2 ballots). However, the Board voted to accept these ballots; and

THEREFORE, BE IT FURTHER RESOLVED, the Board of Elections further concluded that the votes cast needed to be increased from 962, as reported on the County Clerk's Official Elections Results, to 982. The difference is hereby explained that the twenty vote by mail ballots, which were hand-counted on Election Day, were inadvertently not included in the certified results.

THEREFORE, BE IT FURTHER RESOLVED, the Union County Board of Elections does hereby certify and report the results for the election of Members, Board of Education, Township of Union are as follows and the outcome of the election remains the same:
