FEE SCHEDULE & DESCRIPTION OF SERVICES 2021-2022 School Year

123ABA is proud to provide quality ABA services through proven innovative techniques that foster an environment of collaboration, communication, and connection between our therapists and our learners. The following are projected fees for our professional services.

<u>Direct Individual ABA instruction</u>: One on one therapy conducted in the home setting designed to teach and enhance a variety of skills using the principles of Applied Behavior Analysis (ABA). Teaching techniques and strategies include, but are not limited to; verbal behavior, intensive teaching, discrete trials, task analysis, errorless learning, and error correction.

FEE: \$70 per hour

<u>Supervision & Program Development</u>: A BCBA will set up a home/school program with appropriate goals & objectives for each learner by completing utilizing appropriate assessment tools (ABLLS, VB-MAPP, etc.) If there is already an established program our BCBA will continue to ensure there is consistency and continuity for each learner and family.

<u>Functional Behavior Assessment (FBA):</u> A functional behavior assessment will be conducted to gain insight too and hypothesize the function(s) of each learner's behavior. A written description of the procedures utilized during the assessment as well as the results with recommendations as to how to best address these behaviors.

Behavior Intervention Plan (BIP): A behavior intervention plan will be developed based on the results and findings of the FBA when a BIP is deemed as a necessary A written description of the procedures & protocols will be outlined to address the behaviors of concern. Staff training will also be available to ensure consistent and accurate execution of the plan.

FEE: \$125 per hour

Behavioral consultation/observations/meetings/training with written recommendations: An observation for a learner demonstrating challenging behaviors may be warranted at times to determine appropriate reinforcement procedures and/or supports to address various behaviors. Consultation for staff of a challenging learner may be warranted to determine appropriate teaching strategies/styles to ensure learning is optimal. Team meetings and/or IEP meetings that occur for learners may involve our therapists and will gladly attend to offer expertise and information on the assigned learners.
