Superintendent's Report:

Dr. Taylor introduced Mr. Matthews, the principal of Washington Elementary School, who will presenting the student spotlight.

Mr. Matthew stated the following:

Despite going through a very difficult struggle with brain cancer, Camryn Dudek remains optimistic and happy. Camryn's sister, Ryann Dudek, is so supportive and loving with her sister. Camryn and Ryann Dudek are extremely resilient. They refuse to allow an illness to dictate the tone of their lives. Camryn and Ryann insist on seeing the world in a positive light. I for one become so inspired when I see anyone, much less a child, who refuses to let an obstacle, even an obstacle like cancer, to bring them down.

Camryn, you are brave and beautiful! Ryann, you are kind and compassionate! Together you are showing the world how beautiful life is even when, maybe especially when, we are struggling. We are at a good place to talk openly about those important things that foster equity – not just race and ethnicity, but also disability, religion and culture.

Ms. Santana stated thank you for our paras but it is not enough. Never should our paras have left and gone to ESS. I will fight to bring them back. Our substitutes should not be with ESS; it should always go through the district. When they are home, they are accountable to us.

I am a Samantha Pugh fan, I am an advocate of real energy. Any of our vendors, I want them here.

Mrs. Williams stated we are working on bringing back at least 20 paraprofessionals from ESS; we are trying to phase it in. I agree that they should be home.

Mrs. Regis-Darby stated condolences to Emanual's family; Emanual passed away a couple of days ago. He was loved by many students and the teachers acknowledge that he was a good kid. I want to make sure that his family know that I want to send my condolences out to his family because they are going through a really hard time. The kids had vigil a couple of days ago and so many kids turned out for him to celebrate him. They are with him and his family. I want to thank those kids that came out to celebrate his life. He was one of our students and he matters. Dr. Taylor mentioned bringing MSK and changing name to Promise MSK/MBK, that would be a disservice to that program.

Mrs. Williams stated I want to also offer condolences to Emanual's family. He was a friend to my son. I can't imagine what his mother is going through. He was such a good kid. His life was cut so short by nonsense is awful.

Mrs. Regis-Darby stated I was very disappointed that the district did not send anything out to the community. The community is grieving, and kids are hurt. I was livid and upset that this community that says we love our kids and believe in our kids and believe in equity, we lost a member – a kid from our school. Do better here. Mrs. Williams stated in defense of the district, the media presented him as a man from Irvington. I don't think it was people didn't want to be there for his family and show their love for him but our kids were there. People are hurting and the community is grieving because he was ours for three years before he moved to Irvington.

Ms. Santana stated my condolences to the young man. Ann Margaret Shannon invited me to the 4^{th} grade Hannah celebration – all the young ladies playing basketball. I had so much fun. I invite us all to go out and see the girls play on Friday. There were so many parents trying to watch their little girls maybe we can get them a bigger arena so everyone can go see the kids. As a Board we love our children; go out and support our girls.

I invite all parents to fill out the free and reduced lunch application. Fill it out because it is no longer free lunch. We don't want to go back to where we were with the deficit. The only way to fix it is to spread the word to fill out the application. It is a win-win for the parents and kids. If you get free and reduced, it comes with different kinds of perks. You can also qualify for hot spots; a waiver for college applications; lower rates for charges for Chromebook damage.

Comments from the Public:

Bonnie Diaz stated we have a constant bus delay at the high school – almost every single day. It is the same two buses #72 and #49. There is a bus driver shortage is not adequate answer. Anybody who works in transportation knew this day would come when the FSDSA made the rule change in February 2022 and they would have known about it in July 2021. I am a Director of Transportation. Dr. Taylor stated Mr. Benaquista will follow up.

Dr. Kalisha Morgan stated the following:

"I am here to discuss the Equity Consultant and the District Strategic Plan. I am very excited that the BOE voted to hire equity consultants to work with district teachers and that the district strategic plan has an equity goal. Thank you. However, I am disappointed that it took this long. I stressed the importance of equitable practices when I ran for a seat on the BOE in 2018 and when I became a member, often to the disdain of some board members. Two years ago, a group of concerned parents, four of who happened to be board members, drafted a letter calling for action following the murder of George Floyd. While many thought we were out of line for saying that more needs to be done, I was disappointed that the four sitting board members were hit with ethics charges. So, this recent vote on the equity consultant and the implementation of the district strategic plan makes me pause to ask the question, did you have a problem with the message or the messenger?

The district spent \$44,777.29 fighting ethics charges for 4 Board Members over the past two years. These were Board members who challenged the status quo, asked questions, and commented on researched based topics, like reading. These ethics charges were unfounded and ultimately dismissed. So, let's discuss the wasteful spending of \$ 44,777.29. \$44,777.29 can cover the salary of a paraprofessional, \$44,777.29 can be used for professional development in reading because programs don't teach reading, teachers do, and teachers need the skills to do it effectively. I can think of so many other things that \$44,777.29 can cover in a school district, but using this amount of money to defend sitting board members against frivolous ethics charges filed by other board members and their friends is a disgrace.

What troubles me about this the most is that the legal bills in this district continue to grow, and nothing is done about it, and as a taxpayer, this is concerning. It is the Board's responsibility to be good stewards of Taxpayer monies. As Board of Education leadership, do your part and stop filing bogus ethics charges against board colleagues, and tell your friends to stop using ghostwriters to "file" frivolous ethics charges because each time you do this, it costs the district money and it takes away from the very people who you are serving, the students and families of Union Township.

In closing, I ask that we do better as we enter another election cycle. Vote for those who put the needs of children first because this is why they are here. To the BOE leadership and UTEA leadership, I am positive that you will not listen to the messenger, but I hope you got the message."

Ann Margaret Shannon stated UTEA president – thank you for the comments on the SAT prep classes and I look forward to bringing that back. Thank you, Ms. Santana, for your statement on paras. To bring back 20 is not enough; there are 51 vacancies, so we need 51 paras now. Last June the UTEA and the BOE signed the Memorandum of Agreement to get rid of ESS and to bring back all the paras and it didn't happen in September. UTEA did not think it would take years to accomplish; please try to hire 51 paras now. Thank you, Ms. Santana, on your comments about the basketball. I spoke to Mr. Zieser and we are going to see if we can use Kawameeh. I didn't have a coach for one school, I had a teacher who volunteered and didn't know anything, and she went on YouTube and learned about basketball. It was really awesome. She reiterated what she stated at the first Comments from the Public about clubs and then stated I do want to work with the Board regarding the annual review of clubs so this doesn't happen again.

Richard D'Avanzo stated clubs – previously in negotiations we discussed at length going back two years about the clubs. We offered to review it every May – when there are new interests, and the administrators are to review the attendance sheets of the clubs and here we are just wanting to roll it out and have everyone do it for free and if you do it free this year you'll get paid the following year but according to the contract that cannot happen. Hopefully we can figure something out but we stressed this and this has been an issue for a number of years. If you do a yearly review, you will see what students have an interest in and others would fall by the waist side.
