## How This Is Possible How a LegalShield plan works

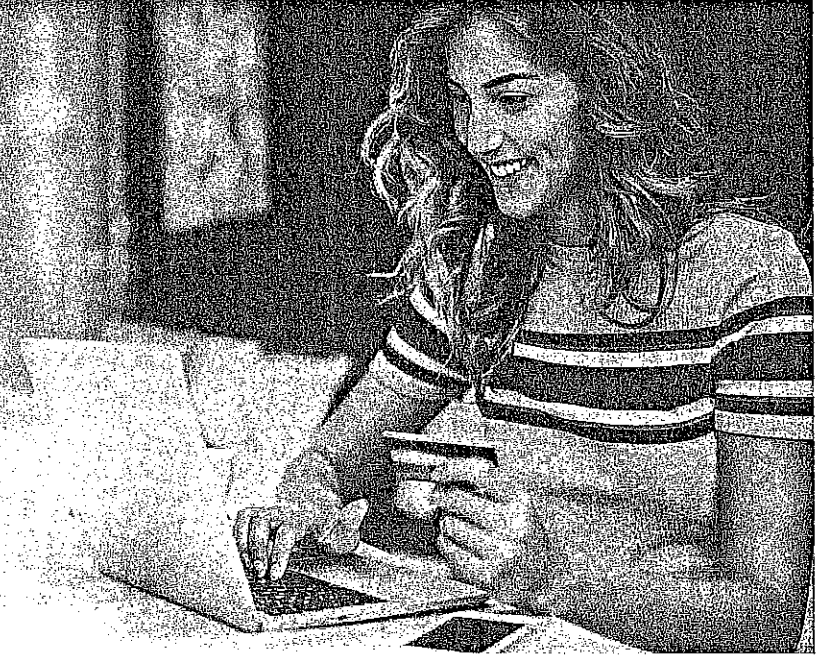
