EIA proposes to assemble the required documentation and update the District's Long Range Facility Plan with a Major Amendment as required by the NJDOE. The documentation will cover all of the education facilities in the district as well as the District offices. The LRFP Update will cover the following services:

SCOPE OF PROFESSIONAL SERVICES

LRFP Major Amenment Update:

- 4. From the Cohort-Survival Spread sheet provided by the District enter the required information into the NJDOE LRFP website
- 5. Based on the above information, update the LRFP on the NJDOE website. Input identified current projects not already included in the current LRFP.
- 6. Submit the Major Amendment to the LRFP through the process on the NJDOE website.
- 7. Provide the required documentation to accompany the Major Amendment submittal via email to the NJDOE LRFP office.

WORK SCOPE NOTES

Our proposal is based upon the following assumptions and qualifications:

- 1. EI's scope of work and fee does not include identification, testing and cost estimating services associated with hazardous materials, such as asbestos.
- 2. Our work will be based on information provided by the District and obtained from their records and existing documents.
- 3. Services covering assessment of existing facilities and infrastructure are excluded.
- 4. Preparation of renderings is excluded.
- 5. Demographic study services are excluded. LRFP update of District demographics is excluded. The District will provide a completed Cohort Survival Spreadsheet as per NJDOE guidelines.
- 6. EI's compensation proposal covers the following project expenses:
 - Travel to and from Township of Union.
 - Reproduction costs for internal and Owner review sets.
 - Normal correspondence and telephone communications.
 - Delivery of all the above documents will be via normal mail services. Overnight or express delivery will be provided at an additional charge.
