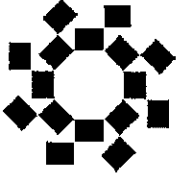

The JFK-Johnson Rehabilitation Institute Vocational Rehabilitation Department, agrees to accept into our **Extended School Year Career Development Program** to begin July 1, 2019 through August 20, 2019. There will be no program July 4<sup>th</sup> and 5<sup>th</sup> (Independence day holiday).

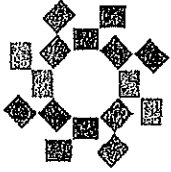


