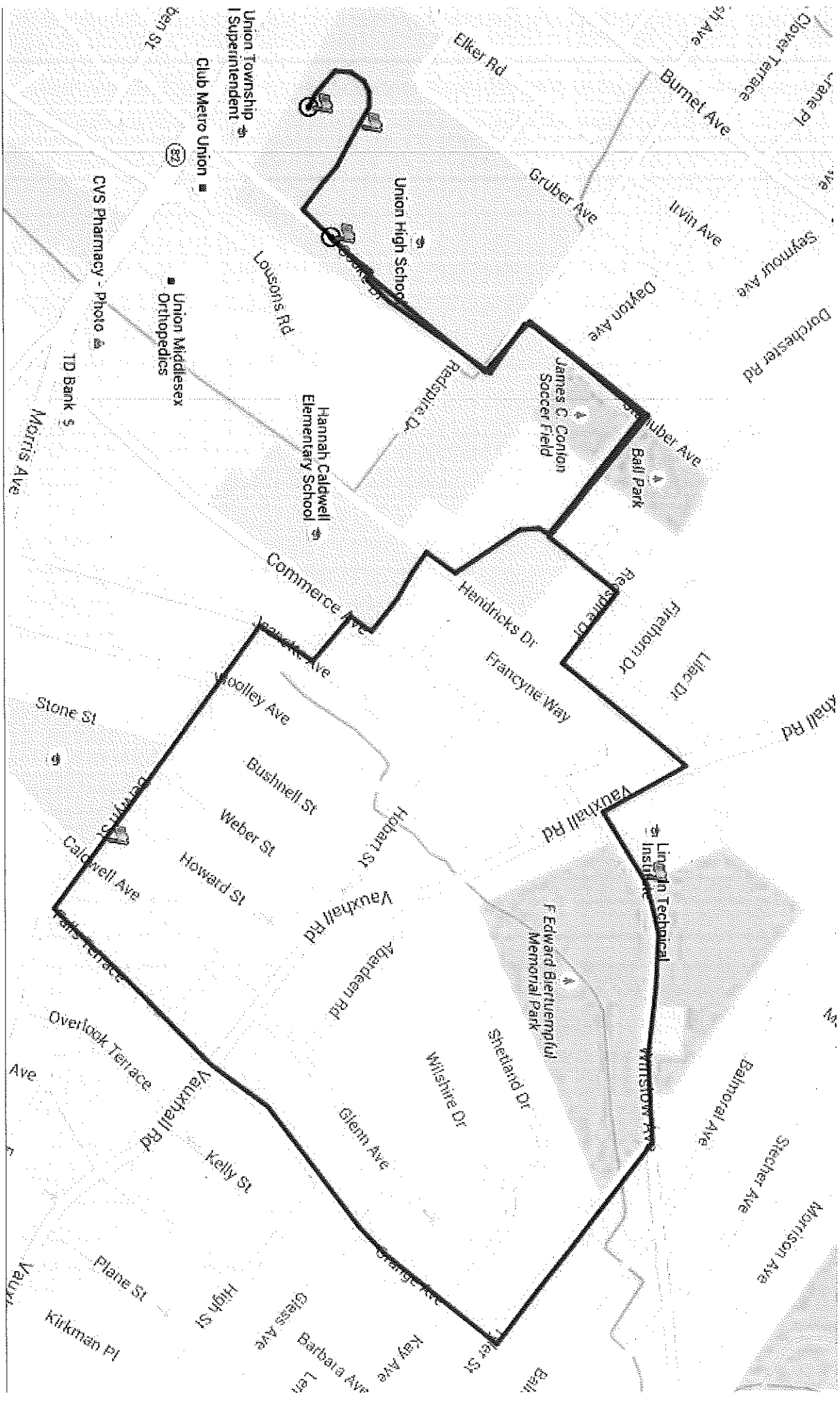

Manny,

For the past year at the request of Mr. Tatum, meetings have been conducted to attempt to resolve a traffic problem/safety concerns at Hannah Caldwell School. Mr. Damato was involved in them until his retirement and Ms. Moses has been involved also. One of the major concerns that needs to be addressed and the Union PD has participated, is to make Hendricks Drive, the street in the rear of the school a one way from the HC school parking lot to the Deron School circle . The one way would be towards Vauxhall Rd. this was presented to the township and they approved it in talks only until we resolved everything we needed to. We have resolved everything. A traffic study was conducted by a private company that the BOE paid for, fencing has been put in place, HC parking lots have been restriped for parking/no parking, the Union Rec Dept. is onboard with us, signs are ordered by Tom Wiggins, the school PTA is paying for movable barricades and the rear HC school lot has been stripped with a walkway. All of the recommendations from the traffic study have been implemented. The last piece of the puzzle is to have the BOE request the street be made into a one way. I spoke to Captain David Tys of the Union PD Traffic Bureau and they agree on the one way. Can this be placed onto the agenda for the BOE to submit a letter to the Township of Union? If there are any questions Kathy DiGiovanni has coordinated all aspects of this project and can answer any of the questions. The

committee has consisted of Kathy Di Giovanni, the school PTA president, a HC staff member, Tom Wiggins, HC Head Custodian, Union PD and myself.
