This is to request an award of a contract without the receipt of formal bids as an Extraordinary Unspecifiable Service [N.J.S.A. 40A:11-5(1)(a)(ii) and N.J.A.C. 5:34-2.3(b)]. I do hereby certify to the following:

1. Provide a clear description of the nature of the work to be done.

A pre-loss disaster plan will evaluate selected facilities to determine what labor, equipment, or materials will be needed directly preceding a disaster or other local emergency. The pre-loss disaster plan allows the contracting unit to prepare to respond to all sizes of disasters or local emergencies in the most efficient manner possible by evaluating and pre-planning varying levels of responses before any event occurs to limit loss exposure and downtime of school operations and services.

2. Describe in detail why the contract meets the provisions of the statute and rules:

These services cover responding to a disaster or emergency which will have an indeterminant scope of work as each facility, the facility's needs, and the level of response required are always uniquely different and must be responded to on a case-by-case basis.

Specifications for traditional bidding could not be drafted because the unique scope of work required for each project cannot be determined until the hours directly preceding an event. This pre-loss disaster planning is intended to assess the response required and create a response plan prior to any event so that the contracting unit can immediately respond to disasters or local emergencies of all sizes. Also, the pre-loss disaster planning limits the governing body's exposure to loss and downtime as compared to not having a pre-loss disaster plan in place because the contracting unit can rapidly develop and perform a unique response due to specific information obtained during the initial evaluation of selected facilities. The service(s) is of such a specialized and qualitative nature that the performance of the service(s) cannot be reasonably described by written specifications because:

(The service(s) is of such a specialized and qualitative nature that the performance of the service(s) cannot be reasonably described by written specifications because: Service Master has a custom methodology and process for responding to losses which was built through real world experience in situations that exist only during a disaster-like environment. These situations and the response required are uniquely different and require a variety of techniques and strategies to facilitate the governing body recovering from a loss. This time-sensitive evaluation and response is not the formal coursework or quantifiable skills that could be traditionally bid because every event requires a unique, tailored response based on the type and size of event which can only be learned via real world experience during disaster-like situations. The response required cannot reasonably be predicted until the hours immediately preceding the disaster or local emergency. The pre-planning and evaluation of selected facilities allows the contracting unit to develop a unique response plan on an expedited timeline that could not reasonably be described by written specifications or efficiently responded to during an emergency.

3. Describe the informal solicitation of quotations:

Service Master was interviewed and demonstrated their abilities through case examples of work done throughout the nation during disasters ranging from localized events to national catastrophes.

Labor Considerations

- 1. The above rates apply to personnel engaged to fulfill the terms of the contract, whether regular full time employees of ServiceMaster Recovery Management (SRM), employees of ServiceMaster franchisees, temporary hires employed directly by SRM or personnel secured through a labor service or vendor source.
- 2. In WA, CA, OR, NY (100 mile radius around Manhattan) and 100 mile radius around Boston, rates will be billed at 1.3X the listed perferred rate. SRM reserves the right to adjust pricing for all rate classifications based on current market conditions in all regions.
- 3. Standard rates will apply to the first 8 hours worked per day. Overtime (1.5 x the standard rate) will be charged for hours worked over 8 hours per day with the exception of Project Managers. Project Managers will be overtime exempt.
- 4. Work on Saturdays and Sundays will be charged at 1.5 x the standard rate for all hours worked.
- 5. In the event SRM personnel are dispatched to perform emergency services between the hours of 5 p.m. and 8 a.m., those hours will be charged at 1.5 times the standard rate.
- 6. All hours worked on SRM recognized holidays (New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve, and Christmas Day) will be charged at 2 times the regular rate.
- 7. In the event that SRM is required to pay time and a half for any work performed, pursuant to State or Federal law, the rates charged will be 1.5 times the standard hourly rate.
- 8. In the event that SRM is required to pay double time for any work performed, pursuant to State or Federal law, the rates charged will be 2 times the standard hourly rate
- 9. Prevailing Rate: (Davis Bacon Act) Prevailing rates will be paid on all applicable jobs that fall under the (Davis Bacon Act) Prevailing Rate Wage. Rates will be obtained from State where work is being performed. THE CUSTOMER will be responsible for notifying SRM if Prevailing rates apply. SRM will adjust rates as necessary.
- 10. To the extent the work under a particular contract is subject to Federal and State minimum wage or hour laws or collective bargaining agreements which modify SRM standard rates and practices, adjustments shall be made to the hourly rate and other labor provisions as necessary.
- 11. When circumstances beyond our control require Personnel or casual labor under contract to be delayed from beginning work, the Standard Rate/Hour will be charged per labor category, per person delayed.
- 12. Travel Time shall be billed at the applicable labor rate for personnel traveling to and from a job.
- 13. Management of Customer Labor force line is utilized when SRM is managing the customer's labor force. The customer is responsible for paying the wages, associated taxes, benefits and insurance for their own employees.
- 14. SRM Reserves the right to add additional labor classifications with rates determined by SRM.
- 15. **** Labor Rates listed exclude environmental, hazardous materials, bio-hazard, and trauma cleanup services.

Travel and Subsistence Considerations

- 1. The company shall be compensated for Per Diem for out of town workers at the rate of \$60 per person, per day for each day personnel (excluding casual labor, unless otherwise negotiated) work on the project plus twenty percent.
- 2. Travel and related expense charges will be invoiced at cost plus 20%.
- 3. SRM shall be compensated for Lodging at the rate of cost plus 20%.

Taxes and Fees

- 1. The rates contained in this Schedule are exclusive of any associated permits or fees. Those Permit costs and Fees shall be billed by the company to the customer and shall be compensated for all such costs on the basis of actual costs incurred for such items plus 20%.
- 2. Federal, state, and local taxes will be charged at cost as required by laws where services are provided. If the customer is Tax Exempt, it must make the company aware of this exemption, and provide the company with copies of all such supporting Tax Exempt status. A Catastrophe Surcharge of 5% of the total billing will be added to all billing to capture the significant costs required in the coordinated response to a catastrophic event which are not specifically addressed elsewhere in the rate schedule. Examples of these charges would be management, administrative support, warehousing, procurement and logistics.
- 2. In the event of a large scale regional event which prevents the use of traditional hotel accommodations, an allowance may be calculated to reflect the necessary alternatives such as travel trailers, mobile housing units, or man camps.

Subcontracted Services

1. Subcontracted services will be invoiced at cost plus 20%.

General Considerations
