Mrs. Conteh-Mackey asked for a moment of silence for the two young girls from Cranford that were murdered. We support the families and respect and honor the two young girls.

Mrs. Faria led the Board in the Pledge of Allegiance and read the district's mission statement.

### Comments from Public (on resolutions in **BOLD** and ALL MATTERS):

Ms. Carbonell - thanked everyone for attending tonight's meeting and that the Board values their input and appreciates their time. She reminded the audience that all comments are to be respectful and constructive, and to refrain from calling out and yelling. The Board is unable to engage in back-and-forth dialogue; however, your comments will be reviewed and considered, and if feasible, the Superintendent or designee will provide a response at a later date.

Virginia Jeffries – indicated that the Board is in violation because there is not enough room for the public. POL-1 – indicated there is no contract in place and asked if there was an RFP. She also indicated that since the policies/regulations are in existence, they must be published as a revision. POL-9 – not properly published.

Christine Zurka – asked do you want us to work harder without a contract? We make a quarter of the teacher's salary. There is a long list of resignations/retirements on the agenda.

James Frazier – president of UCES – he stands in solidarity with those that received a rice letter. The vague rice letter violates fairness. Transparency protects everyone. The UTEA stands firm in equity; not here to divide; our schools thrive in unity. Please commit to transparency.

Ann Margaret Shannon – The UTEA asked that this meeting be moved three times and got crickets. Where are the chairs? Why can't you accommodate? There is no respect. Mediator said not to put the statement out and you did. She is disappointed and disgusted.

Gene Woods –Union solidarity makes us great and some try to break us up. Each member should support all. We are disappointed on how we are treated. Let's find hope as in the Mission Statement.

Christina Birstler – also disappointed.

Peter Leone – social studies teacher and UTEA VP – disappointed that he couldn't access his financials until he signed off on the policies. Our first amendment rights were violated by taking our signs; taking religious holidays off calendar. Every building is out of compliance for special education. Nurses need breaks. Everything lowers morale and is hurting school culture.

Barbara LaMorte – retired employee. She doesn't understand why Ann Margaret received a rice letter. She is a brilliant woman.

Tanya Martin Cooper – she is standing up for Ann Margaret. She indicated that everyone is working for the students, and it is unacceptable that people are being denied space to come to this meeting; it is purposeful exclusion. She also indicated that it was troubling that a rice letter was used as intimidation. What are we modeling for our students – stop disappointing us.

Tabatha Walton – disappointed that you are going after the UTEA president.

Julie Klickus – UVTS president – she is here for Ann Margaret. Governor Murphy has mandated labor history. She was disappointed that Union didn't use this as a teachable moment. She asked that Union do better and not be disappointing.

Glenn Robertson – New Providence Education Association President – disappointed. There are five local presidents here. Mediation impasse happens but targeting union leadership and using a rice notice as intimidation – you are leading an anti-union district.

Katherine Lewis – resigned in January from Union. She indicated that she is more than disappointed and that the district keeps doing unjust things to people and continues to go in the wrong direction. She indicated she was forced to leave and that is sad.

Matt Beverage – English teacher at Burnet – he indicated he is also disappointed. He hopes the district recognizes that they stand here for our kids.

Lydia Arrietta – she indicated that they were trained last week on security and the doors are not working property. She indicated that they are not respected, and she is disappointed.

Amanda Maxwell – 7<sup>th</sup> grade science teacher – she is disappointed in everyone.

Ted Tympanict – as board members, you are the bosses – it all reflects on you. Whoever made that decision, it is not a good look. You are behind the eightball, think of their needs and what they need and asking you to do the same.

Eric Gabriel – teacher in the district – found his passion and disappointed because teachers are being undervalued; something needs to change.
