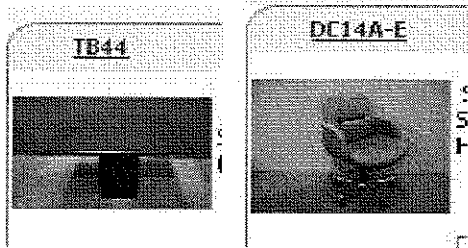

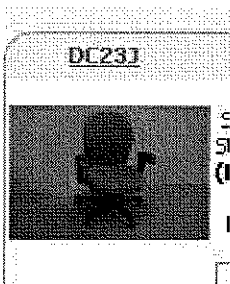
- Matching Waiting Room Chairs (6) and small table –
