#### LETTER OF RESIGNATION – TAYLOR

Letter of resignation from Scott Taylor, Superintendent of Schools, effective November 10, 2023, or an earlier release date per the Board.

#### Superintendent's Report:

Dr. Taylor introduced Dr. Edward Fergus, he was previously approved by the Board to complete an equity audit of the district. Dr. Fergus presented his Equity Report: Findings and Recommendations. A summary is below and the presentation is appended to the minutes.

Dr. Fergus informed the Board that the system needs to be fixed. His examination of the district focused on two research questions: (1) What are the patterns of outcomes by race/ethnicity, gender and free/reduced/full priced lunch eligible groups? And (2) What is the resource, quality and efficiency of school practices? And how much access and opportunity do these practices create?

Dr. Fergus used the following data points: (1) Policies, practices, procedures of tiered intervention supports and curriculum implementation, (2) interviews with school staff, (3) school staff and student surveys and (4) school staff focus groups.

Equity Audit Data Collection Activities: (1) Focus Group Data, (2) Enrollment and Outcome Administrative Data, (3) Surveys and (4) Curriculum examination.

Findings Section 1: Black students, male students, and students eligible for free and reduced lunch have a continuous pattern of disparity during the 2021-2022 school year.

Findings Section 2: Union curricular, instructional and assessment practices demonstrate partial alignment with best practice and consideration of students with disabilities and multilanguage learners. Sample curriculum demonstrates a lack of representative cultural diversity in texts.

Findings Section 3: Union I&RS process does not align across schools and with NJDOE. The Union I&RS process gaps include inconsistent I&RS team notation of activities, match of intervention and student needs and research-based interventions.

Findings Section 4: Students identify the school as having some levels of cohesion, fairness and safety; however, also identify limited belief in whether the educational process is preparing them for college.

Findings Section 5: (a) Staff identify not receiving enough support with implementing interventions; (b) staff maintain deficit thinking and colorblindness beliefs; (c) staff identify having limited cross-cultural experiences; and (d) majority of staff expect higher performing students to attend 4-year college and beyond and expect lower performing students to only achieve 2-year college.

Curriculum: (1) school district needs to conduct a curriculum audit that focuses on curricular and instructional improvement such as intentional diversification of texts, higher order level question development, instructional strategies for SWDs and multi-language learners; and (2) after completion of curricular audit, outline a professional development learning sequence that involves knowledge building, skill practice, coached practices and monitoring of implementation.

Intervention Support: (1) development of a district-wide tiered system of support; (2) extensive review of I&RS implementation processes; (3) development within each school a formal list of tiered interventions for academic and behavioral supports; and (4) develop tools and protocols for the operation of intervention team meetings.

Perspectives on Practice and Diversity: (1) develop and implement a professional learning series that focuses on developing a pedagogical lens that includes an expansive crosscultural competency; (2) continuous assessment of educator knowledge on intervention support systems, curriculum and instruction; and (3) district leadership development of an equity policy/statement that reflects the ethical perspectives of diversity, equity and inclusion.

Dr. Taylor thanked Dr. Fergus and informed the Board that some of these recommendations should be part of the strategic plan.

Mrs. Brens-Watson asked if there has been any progress with the safety concern on Third Street. Mr. Benaquista stated that the Security Manager is setting up the meeting and a synopsis will be sent out to the Board after the meeting.

Dr. Taylor stated congratulations to the now Dr. Benaquista.

#### Comments from the Public:

Jarad Williams stated he is a rising junior at the College of New Jersey, and he is a 2021 graduate of Union High School and he intends to go to law school. He stated he wanted to thank everyone for all their great work.

Louisa Biase stated Dr. Taylor is leaving and over the past two years the district was going where it needed to go. We need to continue to do this work. You will need to follow-up with the presentations recommendations, continue with the high school reform, accountability and digital IDs. You need to make changes for our students. Thank you on the re-registration. We need to continue forward and she will hold you accountable.

Lisa Espendes stated the elementary schools need Spanish instructions. Her husband was a Spanish teacher in Union. We are losing our teachers to Elizabeth and Newark because of salary – salary steps are not competitive. She urges the Board to attract good candidates.
